He stated that Colton Electric commercial and industrial rates, in relation to the other municipalities, fall in the middle of the range and, CED residential rates are lower than our surrounding communities.

Commissioner Razo requested an update on LED lights replacement.


Ms. Gallegos answered with the information requested.
